# MINUTES OF THE ELM RIVER TOWNSHIP BOARD MEETING MAY 20, 2013

**TREASURER'S REPORT:** The Treasurer's report was given by Treasurer Saatio. Bank balances were SNB Gen. Fund \$32,119.05, Tax Fund \$9,501.87, River Valley Savings \$65,986.75. Bills being paid \$11,592.07/payroll \$3,740.00. Motion to approve Treasurer's report: Kelly/Sibilsky, all voted aye.

## FIRE FUND AUDIT PRESENTATION:

Deb Bradford from Rukkila/Negro and Associates presented a progress report of their review of our Fire Department funds: Set up fund for fire equipment and verified USDA fund balances, and tested Fire Department expenditures verifying accuracy of expenses. A draft of suggested internal controls was developed with a need to tweak, also Payroll procedures and processing need further review and refinement. Deb will meet again with Lisa prior to next board meeting to finalize her reports.

Millage review to be in next report.

Questions related to insurance were addressed by Ms. Bradford and verified that charges were correctly processed.

**BUDGET TO ACTUAL:** The continuance of the review by Rukkila /Negro impact the budget to actual, therefore an accurate report isn't available until next month.

**ASSESSOR'S REPORT:** John indicted that our PILT money was scheduled to increase by approx 1/3 with the County get a portion.

John also provided info from the State on transfer of property/ownership when transfer is related to the transferee and when the use is the same. This ruling is to become effective in the system next year, Act #497.
