MINUTES OF SEPTEMBER 29, 2014: The minutes of the September 29, 2014 were approved with correction to the audit statement in the treasurer's report which should read "the 2014 audit is progressing under the guidance of Deb Bradford from Rukkila/Negro and Assoc." TREASURER'S REPORT: Treasurer Saatio gave the report with bank balances as follows: River Valley \$31,017.49, SNB General \$24,640.38, SNB Tax \$466,286.35, Cutwater \$14,527.89. Motion to approve: Sibilsky/Saatio, all voted aye.

BUDGET TO ACTUAL: All accounts were near where we should be at this time. Minor accounting related to payroll data and input wouldn't allow completion of the actual report.

ASSESSOR'S REPORT: The State multiplier will be 1.6%. Two building permits were received from A. Penegor and J. Hoover.

CORRESPONDANCE:

UPPCO reported they have contracted with Asplundh Tree Expert Co. to do tree pruning service along their lines.

U. P. S. E. T. substance enforcement team from Marquette wanted us to consider donating to their effort.

UPPCO announced that a hearing on a rate increase would convene on Nov 18, 2014 in Lansing.

Bids were received for propane with the contract awarded to Keweenaw Petroleum at \$1.74 gal with their price good through April 2015, Ferrellgas bid \$1.749, Settlers \$1.80 and Lagasco/Suburban \$2.29.

NEW BUSINESS: General Election to be held 11-4-2014

PLANNING COMMISSION: No action

FIRE DEPARTMENT UPDATE: Chief Reynolds presented a letter of request for the replacement of the water tanker body. The current unit is leaking in several places and is 70 yrs old. New tanker could cost \$40,000.00. A NFPA approved service tank of fiberglass can be purchased for \$15,000. Two thirds of the money would come from the Women's Auxiliary and 1/3 from the Fire Dept Operating Funds.

There hadn't been any interest expressed in a community ice rink.

Use of the rear portion of the building for fire equipment storage was also requested.
